- Exhibitors, please bring your own table, shade structure, chairs and any other set-up elements required by your particular business. Because this event is outdoors, shade structures are extremely encouraged and must be stand-alone (no staking possible).
- Set up runs from 10:00am to 12 noon on the day of the festival. If you need to set up later, please let us know so we can make special arrangements.
- Exhibitors are responsible for meeting all sales tax requirements.
- Vendor needs to have proper insurance and must provide a copy of its policy or certificate showing necessary coverage.
- Food and drink vendors need to provide health code license and proof of insurance.
- There is no rain date, and no refunds will be given for weather-related issues or if exhibitors are unable to attend.
